5.1. Extinguishing media

Suitable extinguishing media	The product is flammable. Extinguish with alcohol-resistant foam, carbon dioxide, dry powder or water fog.

5.2. Special hazards arising from the substance or mixture

Specific hazards	Containers can burst violently or explode when heated, due to excessive pressure build-up. Bursting aerosol containers may be propelled from a fire at high speed. If aerosol cans are ruptured, care should be taken due to the rapid escape of the pressurised contents and propellant. Vapours may form explosive mixtures with air.
Hazardous combustion products	Thermal decomposition or combustion products may include the following substances: Toxic gases or vapours. Carbon monoxide (CO). Carbon dioxide (CO ₂).

5.3. Advice for firefighters

Protective actions during firefighting	Avoid breathing fire gases or vapours. Evacuate area. Cool containers exposed to heat with water spray and remove them from the fire area if it can be done without risk. Cool containers exposed to flames with water until well after the fire is out. If a leak or spill has not ignited, use water spray to disperse vapours and protect men stopping the leak. Control run-off water by containing and keeping it out of sewers and watercourses. 6.1. Personal precautions, protective equipment and emergency procedures

6.2. Environmental precautions

Environmental precautions Avoid discharge into drains or watercourses or onto the ground. Not considered to be a significant hazard due to the small quantities used.

6.3. Methods and material for containment and cleaning up

Methods for cleaning up Clear up spills immediately and dispose of waste safely. Eliminate all ignition sources if safe to do so. No smoking, sparks, flames or other sources of ignition near spillage. Under normal conditions of handling and storage, spillages from aerosol containers are unlikely. If aerosol cans are ruptured, care should be taken due to the rapid escape of the pressurised contents and propellant. Provide adequate ventilation. Small Spillages: Wipe up with an absorbent cloth and dispose of waste safely. Large Spillages: If the product is soluble in water, dilute the spillage with water and mop it up. Alternatively, or if it is not water-soluble, absorb the spillage with an inert, dry material and place it in a suitable waste disposal container. Wash thoroughly after dealing with a spillage. 7.1. Precautions for safe handling

Avoid exposing aerosol containers to high temperatures or direct sunlight. Keep away from heat, hot surfaces, sparks, open flames and other ignition sources. No smoking. Do not spray on an open flame or other ignition source. Do not pierce or burn, even after use. Spray will evaporate and cool rapidly and may cause frostbite or cold burns if in contact with skin. Do not expose to temperatures exceeding 50°C/122°F. Avoid inhalation of vapours and spray/mists. Avoid contact with eyes.
